009/2019 WELCOME AND APOLOGIES

013/2019 CONSIDERATION OF THE FOLLOWING APPLICATIONS

i 19/00012/TPO - Cemetery and Chapel, Coggeshall Road, Feering

Notice of intent to carry out works to trees protected by Tree Preservation Order (TPO) 58/2000 (attachments 1 & 2). The proposal is to fell four trees in the cemetery, three of which are covered by the TPO. The three trees covered by the TPO are all Cypresses, they are the first three from the south west in the group of six in the group 'G6' of the TPO. The fourth tree, not covered by a TPO, is as shown on the plan, in between T5 and T6. The three cypresses have been condemned as dangerous by the arboricultural adviser to the Essex Diocesan Advisory Committee (Attachment 3). I refer to the part of his report in green. Regarding the Tree of Heaven, please see the part of the tree advisers report in red. He does not regard there to be any immediate danger from this tree, although the very large overhanging branches do represent a danger, and are difficult to prune. REPLANTING The three cypresses can be replaced by three magnolia trees. The tree of heaven is in the hedgerow and can be replaced by a hawthorn. - Cemetery and Chapel, Coggeshall Road, Feering

After consideration we support this application.

ii **19/00113/HH –** 10 London Road, Feering

Demolition of conservatory, proposed single and two storey extensions and internal alterations.

After consideration, we would ask if a party wall agreement is required? Subject to that we have no objection.

19/00044/HH - 48 Watermill Road, Feering

Single storey front porch extension.

After consideration we have no objection to the proposal.

18/02136/FUL - Freebourne Lodge, Feering

Following our comments, further document has been added and the Landscape Team have commented.

BDC would like a further response from FPC as to whether we have any further comments, support, object or have no comment on the proposals.

After further consideration, we have no objection.

18/01161/FUL - Land between The Coach House and The Anchorage

BDC would like to know if FPC have any further views on this application.

After further consideration, we note the ECC Historic Buildings and Conservation advice objection and their note about the listed property curtilage. We would request BDC to confirm the Prested Hall Listed property curtilage, and any impact this may have on the proposals. Subject to this confirmation we have no further comment on the plans to make.

18/02205/FUL - Unit 4 Threshelfords Business Park

Please can you confirm whether you raise any objections the proposal at Threshelford Business Park as it is not clear from your e-mail.

Apologies for the misunderstanding, we did not object but we wanted to check that there was no historic issues surrounding the proposals; however we note that this application has now been granted as at 19 February 2019.

19/00235/HH - 2 Little London, London Road, Feering

Replace existing single storey rear extension with two storey rear and side extensions.

We have no objection to the latest proposals but our previous comments stand on application 18/01279/FUL regarding the side elevation windows being frosted and the ability for cars to exit in a forward gear from the property.

As an advisory we would suggest that the applicant satisfies themselves with regard to a party wall agreement with the adjoining owner.
