18/2016 Welcome and Apologies

Cllr Lees welcomed all to the meeting. Simon Gibbs gave his apology before the meeting

22/2016 UPDATE ON CONDITION OF PLAYING FIELD

At the next meeting a decision will have to be made about the Autumn maintenance.

The clerk was asked to contact Simon regarding the spraying to the matting around the play equipment. Also the Clerk was asked to contact Graham to clear the moss around matting and to address the condition of the other play equipment and to remove any moss that is growing.

23/2016 FENCING ALONG SIDE OF FOOTPATH 16 – update from the Clerk

Danbury Fencing had been out to do a site visit and will be supplying the Clerk with a quotation and an alternative suggestion on design. Kevin Porter will be making a site visit on Wednesday 8th. June to equally submit a quotation.

Once the Clerk has all quotations then this can further accessed at a later meeting. This was agreed by Councillors

24/2016 PLAY EQUIPMENT

Councillors considered the quotation from SutcliffePlay. The Councillors agreed unanimously that the age group that had been quoted for was too low. Also that the design of the equipment did not take into account any disabled children using the equipment.

The Councillors asked the Clerk to seek a revised quotation from SutcliffePlay and to also contact Playquip and Ludus to see if they will quote again. The Clerk informed Councillors that he would try and get the quotations ready for the next meeting.

25/2016 ANY OTHER PLAYING FIELD MATTERS

The Clerk informed Councillors that the mower had been out of action due to a lineage break. This has now been rectified but has put Graham behind with the grass cutting. The Councillors accepted this and asked the Clerk to find an alternative Grass Mower Servicing company for next year.
